 General planning correspondence – Following complaints from several Parishioner regarding Rhondali, Cllr Warneken had spoken to the planner who stated that he could do nothing as there was no outstanding complaint. He advised the council to object again in writing.

  - (a) New settlement consultation Hammerton/Cattal area Development Plan Document (DPD) there is a county wide review of the DPD under the new authority. The current plan will need to be reviewed and submitted again as currently 46% of the land has now been withdrawn. Cllr Warneken will keep us updated.

  - (a) (19.039) Update on the new lighting at the crossroads and installation of the 40 mph road signs for the A59. The council have replied that there is no justification to install further lighting as there have been no serious accidents. There would need to be a capital scheme raised for the signs to be moved which is very unlikely to be approved. The decision was made to leave them where they are
  - (b) (20.131) Report on progress with Speeding signs on Church Lane update required Cllr Warneken reported as survey had been carried out by the council and they felt there was no requirement to alter the speed limits or put up speeding signs.

period is was closed for repairs, she has chased but no further date has been given

- **23.038**Dangerous tree on Church Lane Cllr Johnson reported she had seen the landowner and discussed the issue. Cllr Philiskirk will discuss with then again. The tree at the bottom of East Lane was also mentioned, Clerk will get a tree surgeon to review that and the Church Lane tree if not resolved quickly.
- **Village Garden** It had been suggested at the annual meeting that the village development fund could be used to design and build a garden on the piece of land on the corner of East Lane and Main Street (by the cattle grid) Cllr Lazzerini will work with the Moor Monkton Garden Club on a plan

- 23.041 Rubbish and recycling collections Cllr Wilkinson raised the spasmodic recycling collections of late. Cllr Warneken reported that there was a major shortage of HGV drivers in the council which was causing the problem. They were trying to recruit and train additional drivers. The garden waste is causing a problem as the Lorries can only hold so much before they have to return to the depot.

It was also raised that the recycling team are not concerned when waste is dropped from the bins and do not tidy up. Cllr Warneken suggested pictures be taken in addition to a note of the reg number of the vehicle, he could then report them. He also reported that black recycling bins will be changed to another big bin which will be easier to manage and should stop the problem.
