 - Clerk had produced a draft budget which:
 - o increased standard elements by inflation
 - o built in known additional costs
 - reduced the amount going into ring fenced sums for £1,000 to £500
 - this allowed to accounts to balance without increasing the precept
 - This was debated and agreed

- **(g) To review and agree precept for 2025/26** Precept would remain unchanged for this year at £5920

- 24.079 To review any issues around Neighbourhood Watch and Defibrillator
 - Neighbourhood Watch no issues. It was noted that only information from police /NYC is circulated.
 - Defibrillator the heating element in the box has failed. Due to the age of the box there are no replacement parts available. A new box will be required and will need to be fitted by an electrician
 - Authority was given to action this
- **24.080** (23.039) Village Garden A landscape gardener had been booked to give a quote for the new garden. However, a question was raised as to the ownership of the Land. ACTION Cllr Goddard to investigate
- 24.081 (23.077) Village plan
 - An update was given on the progress of the on line version of the questionnaire which is now ready for testing.
 - The Clerk and Cllr Goddard will user test it and it will be ready to approve at the next meeting
- 24.082 (24.037) Potential funding opportunities (shared prosperity fund)
 - Yorkshire Green funding is available on a rolling year and can be applied for quarterly
 - Village garden would be a good project as it tick a number of the boxes required to secure the funding
 - PC cannot apply for the grant so once ownership is clarified other opportunities will be investigated
- 24.084 (24.061) Path keepers The Clerk has volunteered for this
- 24.085 (24.063) Verge cutting Cllr Philliskirk and Cllr Goddard will progress this
- **24.086 (24.064) Ash trees in Church Lane** Clerk reported no update from Highways and will ask Cllr Warneken for assistance
- **24.087 80**th **anniversary VE day** discussion took place on the best way for the Parrish Council to support this it was decided:
 - There will be a national ringing of Church Bells at 6:30 on the day which the Church in Moor Monkton will do
 - Villagers will be asked to join
 - PC will lay a wreath at the war memorial
- 24.088 To receive report from Councillors/Clerk on any meetings/conferences attended
 - Clerk attended a course on the new Procurement act which will come into force on 24/2/25
 - Any contract under £30k will continue to use PC standing orders
 - There are new procedures for anything above this amount
