24.056 (23.039) Village Garden –

- The Parishioner who was designing the garden is no longer able to do so.
- Cllr Warneken also agreed to ask the Parks department if they would be able to give some advice and failing that agreed there could be a grant available from him

### 24.057 (23.077) Village plan –

- Format and questions were broadly agreed, a few changes to be made
- It was agreed that paper copies should be the last resort with a link to be published:
  - In the minutes
  - On Facebook
  - On the website
  - On a poster on the noticeboard (along with a QR code)
- Cllr Goddard and the clerk to speak to our technical expert on the best way to provide the technical platform for this
- **24.058** (23.080) Subsidence in Church Lane no update from Highways, with no indication that one will be received. The pothole in Red House Lane to be reported by the clerk but otherwise this will be removed from the agenda unless further issues occur
- **24.059** (24.037) Potential funding opportunities (shared prosperity fund) until the results of the survey are known and a project identified, additional funding will not be able to be applied for
- 24.060 (24.038) NYC Community awards no further update, clerk to chase
- **24.061 Path keepers** this is an initiative championed by Cllr Warneken
  - He reported that there are only 3 officers in the County to manage pathways. They
    also manage the growing number of volunteers, giving training and support where
    necessary.
  - Cllr Warneken will be arranging a meeting for all his parishes for the council to explain what would be required of a volunteer.
  - It was agreed to ask for volunteers for Moor Monkton. Please contact the clerk if you are interested in finding out more
- **24.062 Citizens advice donation** agreed to donate £50 as previous years

#### 24.063 Verge cutting –

- It was discussed and agreed that the verges need cutting more regularly and further in towards the main hedge to remove the Himalayan Balsam.
- It was agreed to continue discussion with providers to achieve the best outcome and further agreed that up to £500 per annum could be spent using the most appropriate provider

#### 24.064 Ash trees in Church Lane –

- Clerk has asked Highways to do a survey of the Ash Trees on Church Lane to establish which are the Councils responsibility and which the Landowners.
- Once established they will approach the land owners to agree a course of action for the trees that need action.

 Councillors discussed the possibility of contributing in the future to the planting of replacement trees which will be discussed further when a plan for the existing trees was agreed

## 24.065 Remembrance day wreath at the War memorial –

- It was agreed that the Council would lay a wreath on the war memorial for remembrances day.
- The Church warden said there is likely to be a service at the church on 10th November. She will confirm along with the time of the service.
- Clerk was given authority to spend up to £50 on the wreath.
